BACKGROUND

During previous terms of Tillsonburg Town Council, the Museum Advisory Committee had an Annandale House Fundraising Sub-Committee. For the 2022-2026 Term of Council, the previous Museum Advisory Committee had merged with other committees to form the Museum, Culture, Heritage and Special Awards Advisory Committee. The Annandale House Fundraising Sub-Committee had not been re-established since that time.

A Fundraising committee could raise funds for projects and repairs at the Annandale Museum, which would potentially have a positive impact on the budget, either by applying the funds directly to the budget, or transferred to the Annandale House Trust for future use.

The Annandale House Trust was established for purpose of generating funds for the restoration, refurbish, development, and promotion of the Annandale House and the Museum's collection. The Trust's balance as of Dec. 31, 2023 was \$168,519.

Trust funds are to be used for capital repairs and enhancements to the Annandale House, outbuilding and grounds that are consistent with maintaining and/or restoring the National Historic Site. Trust funds may also be used for acquisition of items for the Museum collection or for expenses related to the preservation, storage or display of the items in the collection.
