RECOMMENDATION

THAT Council receive Report DCS 19-29 Town Hall Project Committee – Proposal Summary and Public Engagement Process;

AND THAT the Town Hall Project Committee be authorized to move forward with the public engagement process as outlined in this report.

EXECUTIVE SUMMARY

The purpose of this report is to provide Council with an overview of the three Town Hall proposals received by the Town and to provide additional information on the public consultation process. The public consultation is intended to meet the Town's commitment to the community consistent with the goals and objectives of the Town's Public Engagement Guidelines (Bylaw 3880). This report will serve as the launch of the public engagement process for this project. This report is being provided on behalf of the Town Hall Project Committee.

BACKGROUND

Council approved the following resolution at their August 12, 2019 meeting:

THAT Council receive Report DCS 19-20 Town Hall Project Committee – Status Update and Public Consultation as information.

However, Council requested that they be provided with an overview of the proposal information that would be used in the public consultation for the project. In that regard, staff is providing a summary of the following information:

- Building Elevations;
- Building Floor Plans; and,
- Site Plan of the property.

This information has been included Appendix A, B and C to this report.

CONSULTATION/COMMUNICATION

The Town Hall Project Committee has made a number of suggestions to consider for the Public Consultation sessions:

- Provide a variety of Open House dates and times;
- Consider starting the consultation with a social event;
- Provide feedback sheets for residents to submit;
- Provide summary financial information; and,
- Ensure open house information is shared widely and to Town Advisory Committees, the Chamber of Commerce, BIA, etc.

Based on this, the following schedule for public consultation is being recommended:

The following questions will form the basis for the feedback sheets that will be provided to residents for their input:

- Do you know where all of the Town's offices are now? If yes, please describe.
- Do you feel that the Town's current way of doing business with different departments spread out across multiple locations serves the public well?
- Do you believe that consolidating the majority of the Town's administration into one central location is a good idea? Why or why not?
- After reviewing the proposals, what design elements do you like best?
- After reviewing the proposals, what design elements do you like least?
- Is there anything missing from the proposals that should be considered/included?
- Do you believe that consolidating Town operations will provide additional value to taxpayers even if it means increased costs?
- Do you have any other questions or comments that you would like to be considered by the Town in making this decision?

As Public Engagement is a Town responsibility, the information gained from the process will be provided to Council for their consideration.

FINANCIAL IMPACT/FUNDING SOURCE

There are minor financial impacts associated with the public consultation including refreshments as appropriate as well as staff resources to summarize and prepare the information for release, launch the identified website and related infrastructure and review the input received.

Due to workload, the Economic Development & Marketing (Communications) department is unable to provide full communications support for the public engagement process. Hence, staff will be looking to retain communications support and this will also result in additional costs.

The lease and additional costs associated with a new Town Hall will be brought forward along with a recommendation at a future date.

A summary of the proposals is as follows:

- Building size ranges from 25,025 square feet in the E&E McLaughlin proposal to 26,905 for the S.E.M Construction proposal and 27,198 square feet in the Dancor proposal.
- Average Annual Lease Costs over the 30 year period range from approximately \$800,000 (\$29/square foot) to \$850,000 (\$31/square foot).

The Town is currently paying approximately \$217,500 in annual lease costs for the 12,000 square feet of space it is currently leasing in the Town Centre Mall. Consolidating additional staff into an expanded presence in the mall would also result in additional costs and these will be brought forward the future.

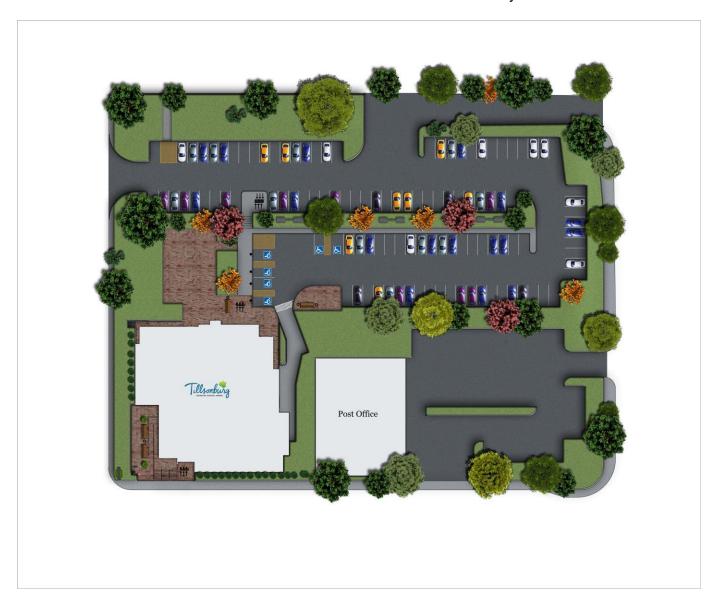
There is no commitment for the Town to proceed with any proposals received.

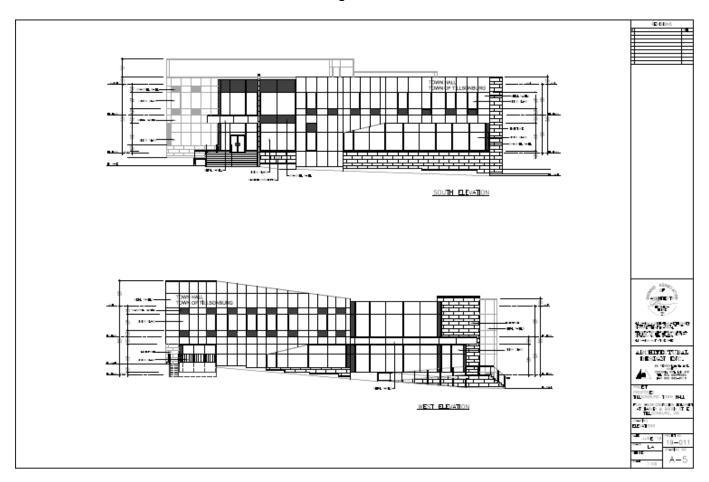

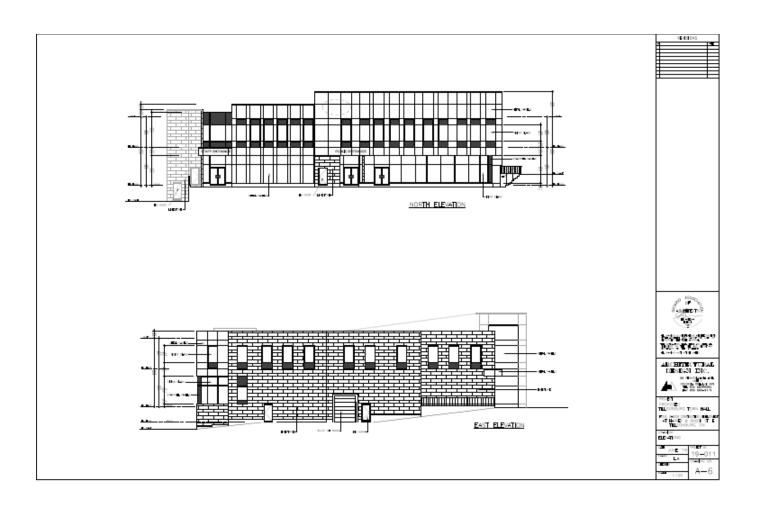

Building Elevations

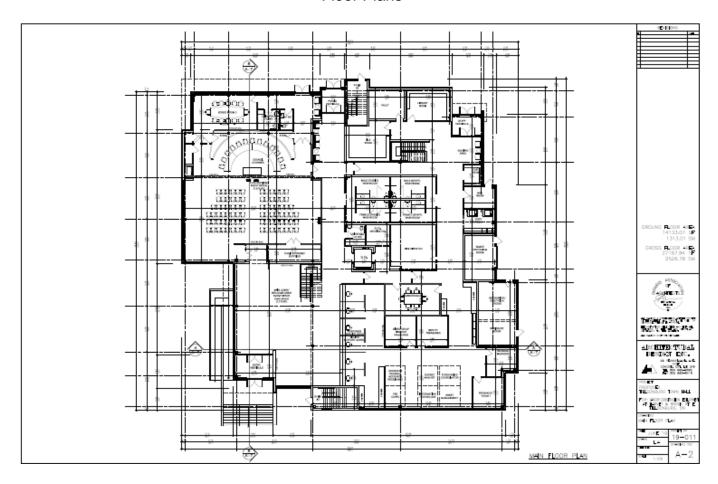


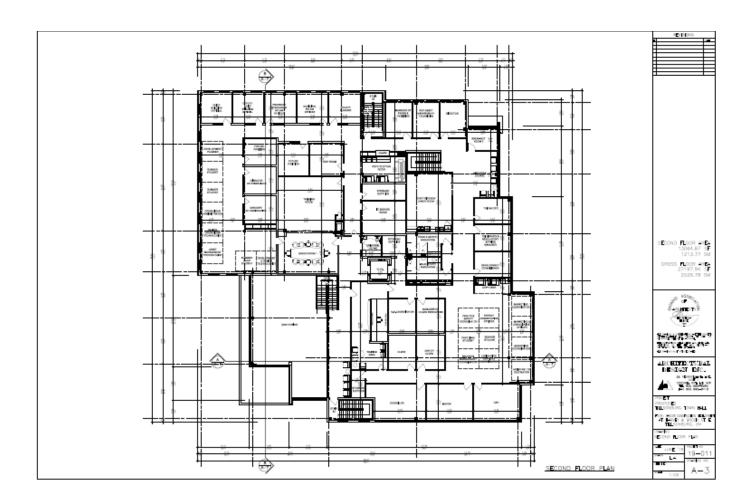


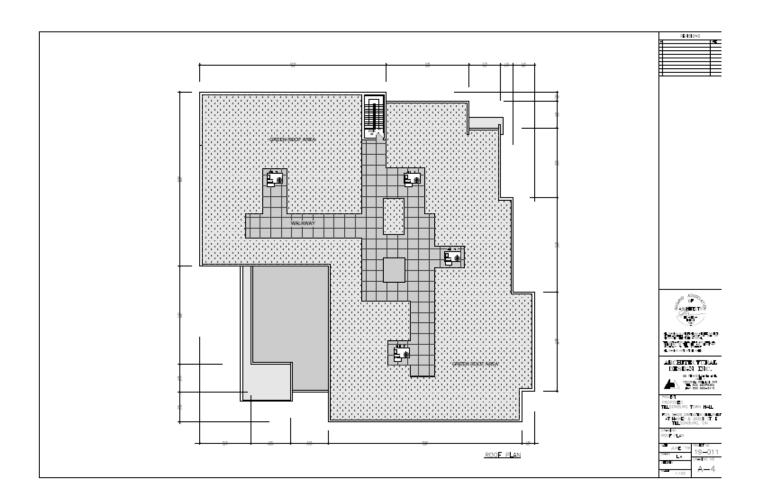

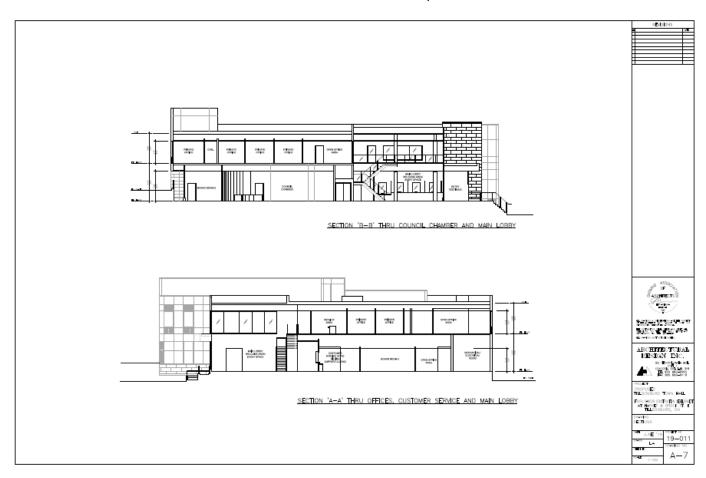
Floor Plans





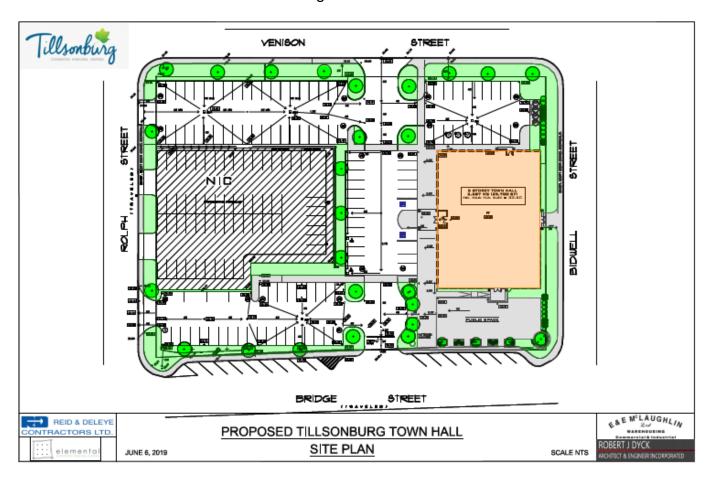


Cross Section - Public Space

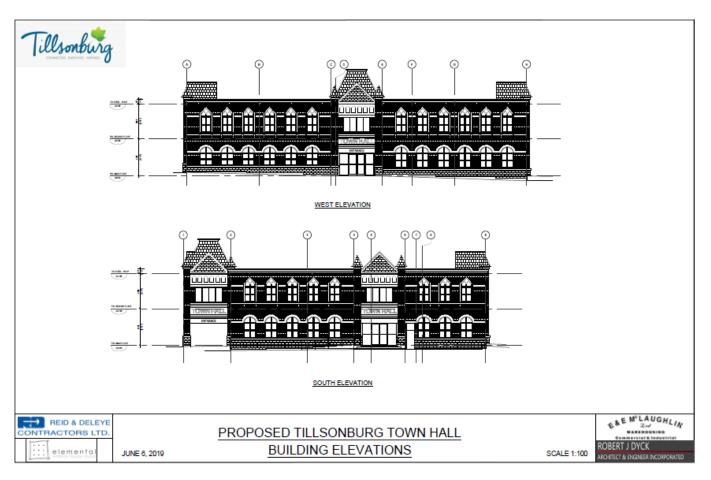


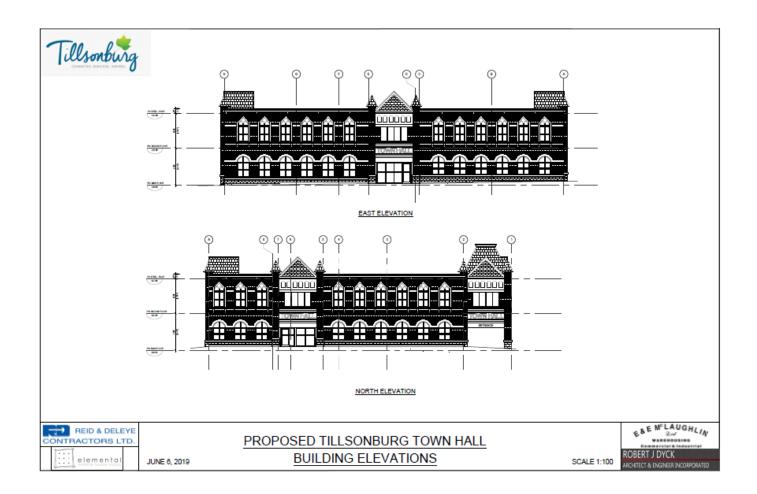

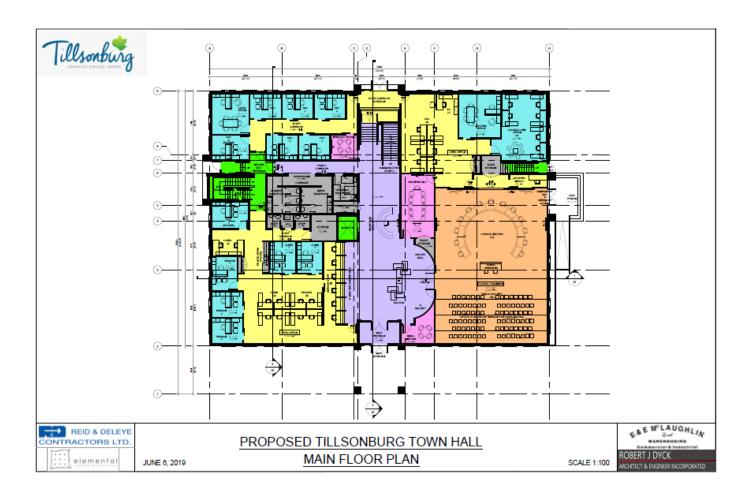
PROPOSED TILLSONBURG TOWN HALL PERSPECTIVE

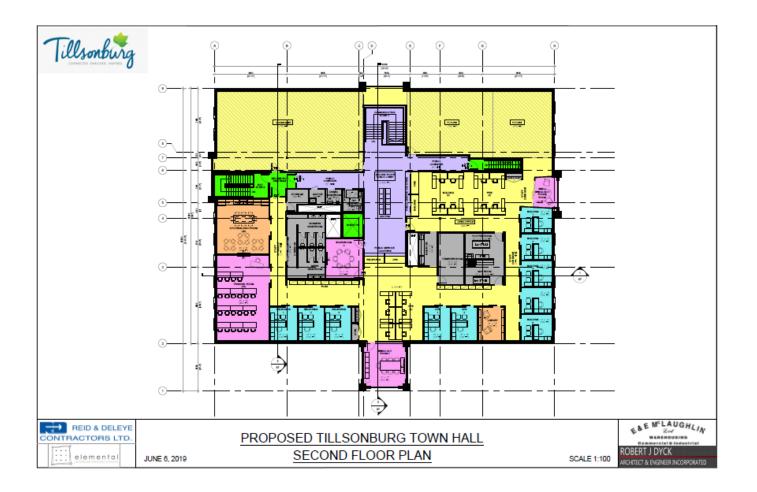

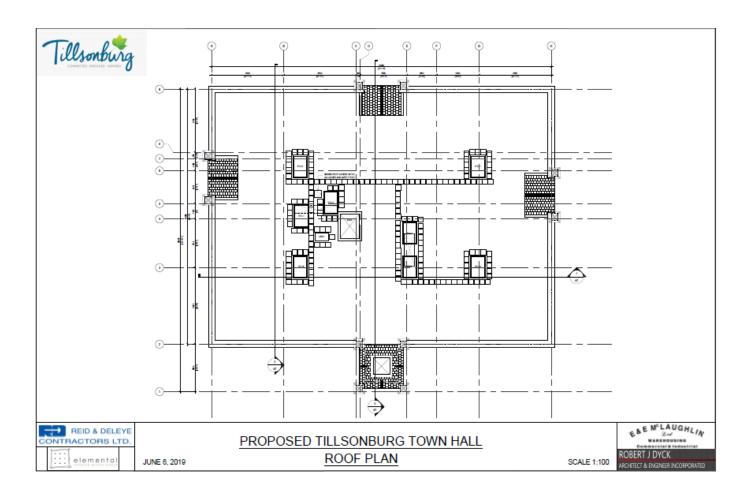

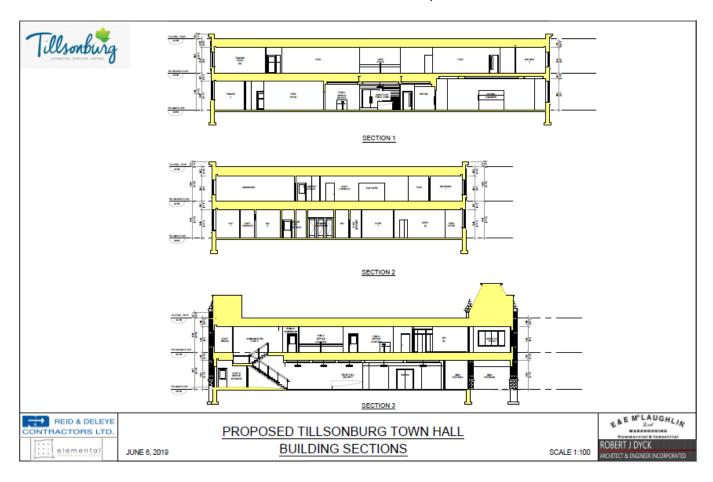








Cross Section - Public Space

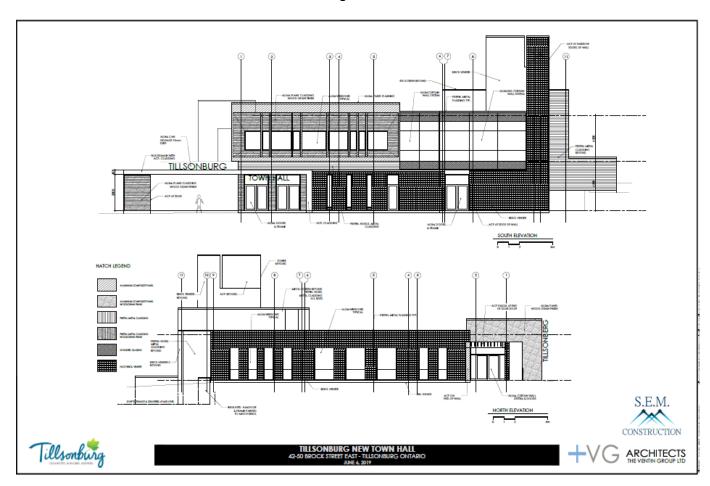


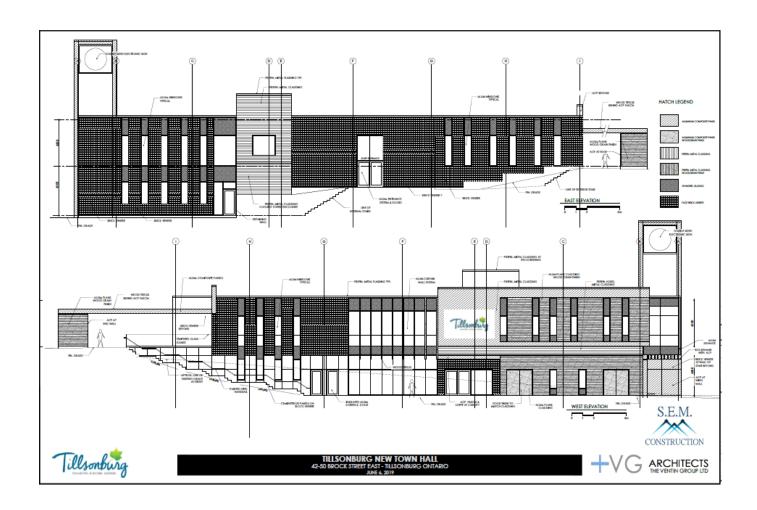

Site Plan - Corner of Brock Street East and Harvey Street



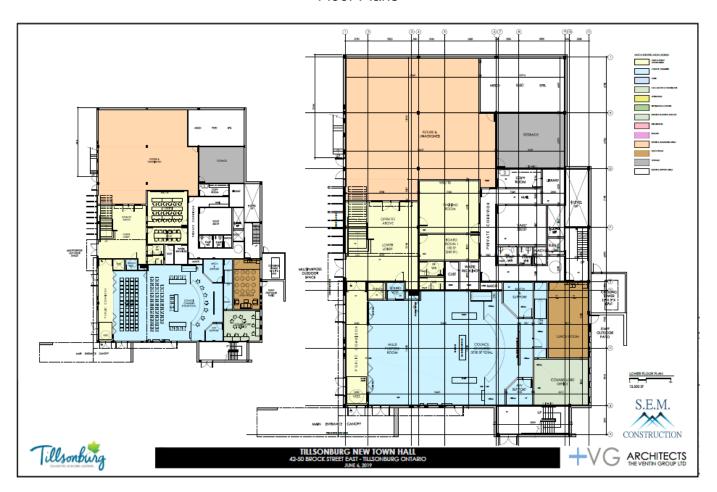
Building Elevations



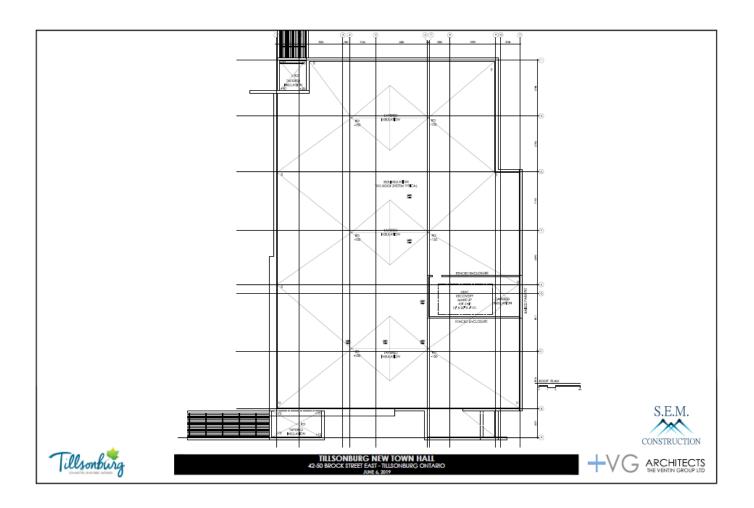




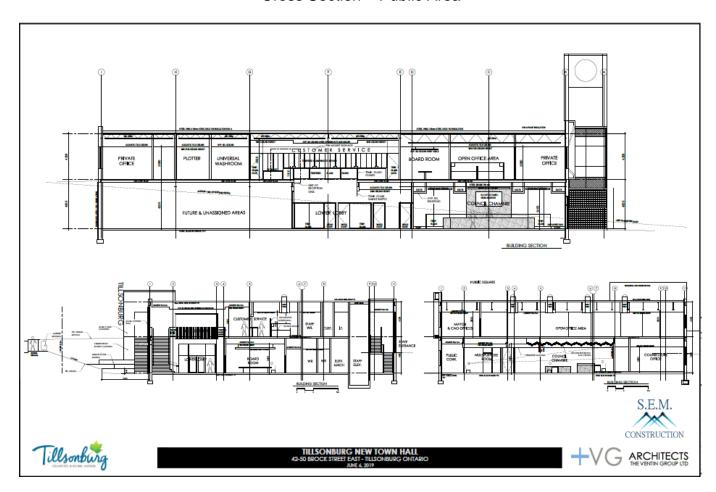
